DISCIPLINE PROCEDURE

In the event of any person acting on behalf of Bournemouth Sports Football Club whether as a Manager, Coach, Club Official and / or Player / Spectator is found proven to contravene one of the Clubs Policies or its Constitution, the Club will use the following procedure. This procedure may also be used following a proven complaint at the Club Committee's discretion.

Managers, Coaches and Club Officials

If, following an FA Disciplinary, a complaint or an incident I am found proven to breach the FA Rules of The Association and / or the Club Policies and Constitution, the Club will initiate the below requirements per offence, in addition to the FA's chosen disciplinary procedures and stipulated punishment:

- 1st Offence – Be required to re-read, re-sign and return for file the Managers, Coaches and Club Officials FA Respect Code of Conduct. Pay any fine and / or administration costs occurring.
- 2nd Offence – Be required to meet with the Club Committee to personally explain the circumstances and provide any mitigating circumstances. Pay any fine and / or administration charges occurring.
- 3rd Offence – The Club Committee will base their decision using the below list of actions and I will be liable for any fine and / or administration costs incurred.

I understand that if I do not follow the Code, any / all of the following actions may be taken by my Club, County FA or The FA:

I MAY:

- Be required to meet with the Club, League or County Welfare / Safeguarding Officer
- Be required to meet with The FA / County FA Refereeing Official or committee
- Be suspended by the Club from attending matches or taking training sessions
- Suspended or fined by the County FA
- Receive a formal warning from the Club Committee
- Be required to leave the Club
- Be required to attend a course relevant to the offence

IN ADDITION:

- My FA Coaching Licence may be withdrawn (if applicable)
- Any previous charges or offences may or may not be taken into consideration, depending on relevance

I accept that I am liable for any costs incurred if I am an adult over the age of 18.



DISCIPLINE PROCEDURE

Players / Spectators

If, following an FA Disciplinary, a complaint or an incident I am found proven to breach the FA Rules of The Association (including cautions / misconduct charges) and / or the Club Policies and Constitution, the Club will initiate the below requirements per offence in addition to the FA's chosen disciplinary procedures and stipulated punishment:

- 1st Offence – Be required to re-read, re-sign and return for file the Young Players / Spectators FA Respect Code of Conduct (along with my parent / guardian / carer where U18). Pay any fine and / or administration costs occurred (If I am over the age of 18). If U18, then parent to pay any fine/admin costs.
- 2nd Offence – Be required to meet with the Club Committee (along with my parent / guardian / carer where U18) to personally explain the circumstances and provide any mitigating circumstances. Pay any fine and / or administration costs occurred (If I am over the age of 18). If U18, then parent to pay any fine/admin costs.
- 3rd Offence – The Club Committee will base their decision using the below list of actions and I will be liable for any fine and / or administration costs incurred (If I am over the age of 18). If U18, then parent to pay any fine/admin costs.

I understand that if I do not follow the code, any / all of the following actions may be taken by my Club, County FA or The FA:

I MAY:

- Be required to apologize to my team-mates, opposition, Match Officials or club member
- Receive a formal warning from the Manager or the Club Committee
- Be substituted (Players)
- Be suspended from attending training / matches
- Be required to leave the Club

IN ADDITION:

- My Club, County FA or The FA may make my parent or carer aware of any infringements of the Code of Conduct
- The FA / County could impose a fine and suspension against my club
- Any previous charges may or may not be taken into consideration, depending on relevance
